

Louisiana State University of Alexandria ("LSUA") Athletics Mascot Logo Contest Terms and Conditions

Please read the **Terms and Conditions** carefully. Any person submitting a logo design, image, picture, or photograph ("Logo Design") to LSUA for the Logo Design contest (the "Contest"), agrees to be legally bound by the Terms and Conditions.

1. The Contest will be held from August 1, 2017 to August 31, 2017. To be eligible, any Logo Design must be submitted via email to submissions@lsua.edu as a JPEG in both black & white and color version by August 31, 2017, at 11:59 PM CST. Top selections will be required to send any Logo Design in a vector file format, .ai or .eps. LSUA may, at its sole discretion, extend the duration of the Contest at any time without prior notice. Entrants' participation in the Contest during any extended period shall be governed by these Terms and Conditions.
2. The Contest is open to any person in any country, except where prohibited by law.
3. By submitting a Logo Design to LSUA, you confirm that this work is completely your own and does not contain any prior copyrights, trademarks, patents, and any other intellectual property that is not your own in the Logo Design.
4. By submitting a Logo Design to LSUA, you agree that the Logo Design shall become the property of LSUA, and hereby grant all right, title and interest in and to the Logo Design, including, but not limited to, all copyrights, trademarks, patents and any other intellectual property in the Logo Design to LSUA.
5. LSUA reserves the right to use any Entrant's Logo Design, in whole or in part, including any modifications or amendments thereto. Submission of a Logo Design in the Contest does not obligate LSUA to use such Logo Design.
6. LSUA reserves the right, in its sole discretion, to use any Contest participant's name, age, photograph and place of birth or current residence for the purpose of publicity, advertising, marketing or promotion without prior compensation or notice.
7. The decision of LSUA regarding any winner of the Contest is final, including, but not limited to, any decision that no winner will be chosen.
8. LSUA reserves the right, in its sole discretion, to disqualify entries that do not meet these Terms and Conditions. The decision of LSUA regarding any disqualifications is final.
